

PRIVACY AND DATA PROTECTION POLICY

DOLCE VITA TEJO - INVESTIMENTOS IMOBILIÁRIOS S.A is committed to protecting the privacy of all visitors to this website and has, to that effect, prepared this protection policy.

DOLCE VITA TEJO - INVESTIMENTOS IMOBILIÁRIOS S.A guarantees respect for the privacy of visitors to this website ("User" or "Users"). The visit to this website does not, of itself, imply the automatic registration of any personal data that identifies the User. However, the use of specific content may imply the provision of personal data by Users.

This Privacy and Data Protection Policy regulates the collection and processing of personal data provided by Users, as well as the exercise of their rights relative to these data, under the Personal Data Protection Act in force.

To this effect, and to ensure that all personal data is treated and protected according to the new Data Protection Regulation, we request that you read the new privacy and data protection policy carefully.

PERSONAL DATA

Personal data corresponds to any information of any nature, regardless of its support, that identifies or may identify an individual.

Through this Website, and, depending on the end to which data is collected for, the following personal information may be collected: (i) name, (ii) date of birth, (iii) contacts (telephone and email).

COLLECTION AND PROCESSING OF DATA

DOLCE VITA TEJO - INVESTIMENTOS IMOBILIÁRIOS S.A is the entity responsible for the collection and processing of the personal data of Users.

The personal data collected will be processed and stored electronically by DOLCE VITA TEJO - INVESTIMENTOS IMOBILIÁRIOS S.A or by its subcontracted entities and can be used in newsletters and/or to contact the subjects with promotional and similar messages.

DATA CONSERVATION

Personal data will be stored until the fulfilment of the end to which they were collected, after which they will be eliminated.

TRANSFER OF DATA

DOLCE VITA TEJO - INVESTIMENTOS IMOBILIÁRIOS S.A will not share personal data with third parties, without prior express consent from Users.

Without prejudice to the above, in the scope of its activity DOLCE VITA TEJO - INVESTIMENTOS IMOBILIÁRIOS S.A may turn to third parties for the provision of certain services, which may require, in some situations, access by said parties to users' personal data.

In such circumstances, DOLCE VITA TEJO - INVESTIMENTOS IMOBILIÁRIOS S.A will require that the third party abides with the applicable legislation regarding the Protection of Personal Data as well as commits to adopting the technical and organizational measures necessary to protecting personal data from destruction (illicit or accidental), accidental loss, change, sharing or unauthorized access and any other form of illicit treatment.

Personal data may also be shared to comply with any legal or judicial order.

DATA COMMUNICATION

SECURITY MEASURES

Personal data will be processed and stored digitally and/or on paper.

To this end, it uses security systems, rules and other procedures to guarantee the protection of Users' personal data, as well as to prevent unauthorised access to the latter, its improper use, disclosure, loss or destruction.

However, please be aware that when providing personal information online, there is always a risk that third parties may intercept and use this information.

Additionally, and within the terms referred in the above paragraph, DOLCE VITA TEJO – INVESTIMENTOS IMOBILIÁRIOS, S.A. commits to reporting the violation of personal data to the owner of the data, in the terms of applicable legislation.
